## School governance events and briefing programme 2018-19

We are pleased to offer governors and clerks our new streamlined governance events and briefing programme for 2018-19. The programme gives governors and clerks the opportunity to attend termly briefings and in addition we have introduced a new one day training event on Saturday 23 March 2019 which will include a range of training sessions on key areas including the interpretation of data, finance and safeguarding. We strongly recommend that governors attend this event. The Department for Education has clearly defined the responsibilities of governing bodies to ensure that a budget is set aside for governor training and liaison with the LA takes place to attend training. The DfE Governance Handbook and School Governance constitution regulations both emphasise the importance of new governors attending induction and governors having the skills in areas that include the interpretation of educational and financial performance data.

In addition the Competency Frameworks for Governance and Clerks clearly define the roles and responsibilities of governors and clerks, giving the key competencies of effective governance and clerking.

The programme below gives an outline of each session with the competency that will be covered during the session.

We appreciate that governors may not always have the time to attend governor training, in view of this we have included NGA membership in our Governor Support Service package for 2018-19 which includes the NGA online training package.

#### **Briefing fees per session**

Schools that do not buy back are still able to access any amount of the programme. In this case schools will be invoiced for each place taken up. The cost of training will be charged at the following rate: full day £120 and part day £60. Schools will be invoiced on a termly basis.

### Booking arrangements

We have simplified booking arrangements which, in line with GDPR, will ensure that we collect only the data we need to manage bookings and charging.

At the bottom of each course description is a link to a booking form on Google Forms. When you book a place/places you will be required to provide the name of your school, the name of the school contact and the email address of that school contact. You will have an opportunity at that time to book on each of the courses in that series. You will have an option to opt into or out of further emails from the Governor Support Service about future opportunities.

Once you have booked a place you will be sent a notification of booking. The contact details that you have supplied may be used to circulate further information about the course programme and the PowerPoint slides that were used on the training. On the rare occasion that we need to cancel a training event, we will use the same contact details to inform you of this.

The role of the SEN governor is to hold school leaders to account for the provision and outcomes for SEN pupils. You will want the school to be able to demonstrate that, from their starting points, pupils with SEN achieve as well as they can.

At these termly seminars we will share examples of how SEN governors monitor and evaluate the effectiveness of provision for SEN. We will ensure that you are understand the school's statutory responsibilities and are well prepared for an inspection.
